Please Note: This tournament agreement is valid only for groups of 50 players or larger and accommodates “shotgun” starts only. All tournaments will be booked on a first come, first serve basis. Tournaments may be booked in a manner to support maximum usage of the golf course at given time. In the event your group has less than 50 players, we will be happy to make arrangements for a block of tee times.

Tournament Responsibilities

The tournament coordinator will provide Cherry Oaks with a typed copy of pairings by group at least 5 days in advance of the tournament date.

Liability

The tournament coordinator shall be responsible for any and all damages to any equipment or property on the golf course.

Food and Beverage

The tournament coordinator agrees to **purchase all beverages from Cherry Oaks, no “donated” beverages will be allowed on the course.** Personal coolers and the like containing beverages may **NOT** be brought onto the premises or into the clubhouse.

This provision will be strictly enforced

Cherry Oaks offers a couple of food menu choices (see page 4). We also offer a variety of snacks throughout the day.

If in the event you choose to use a catering service or bring in pre-prepared food, there will be a \$1.00 per person surcharge. In this instance, Cherry Oaks will not be responsible for napkins, utensils, plates or the like.

A beverage cart will be made available on the course during the tournament for a \$50.00 fee. Only Cherry Oaks employees will be allowed to distribute food and beverages from this cart. I.E., Cherry Oaks will provide its own drivers, however, event photographers and support staff are able to ride along if desired. Additional beverage carts can be supplied for \$50.00 per cart per day.

Gift Certificates and Prizes

The tournament coordinator agrees to check Cherry Oaks pricing on all golf related prizes. The Clubhouse Manager is available to help with the prize selection and gift certificate options. Donated golf related prizes are acceptable.

Cherry Oaks will always donate a round of golf for four players (carts not included) to tournaments hosted on site. (50 player tourney minimum)

Dress Code

The tournament coordinator will be responsible for the participants to be properly attired. Proper attire is defined to be regular and customary apparel worn by golfers. Collared shirts are preferred for men. Soft spikes or tennis shoes are required, no metal spikes or cowboy boots.

Player Guarantee

A \$200 deposit is required. The tournament coordinator agrees to guarantee the number of players at the time the agreement is submitted. The tournament coordinator may change the number of players as it becomes necessary, but is responsible for full payment of all players unless cancelled at least 8 days in advance. **Failure to cancel tournament at least 8 days in advance will lose the \$200 deposit.**

Inclement Weather and Uncontrollable Events

In the event of inclement weather and/or other uncontrollable events, Cherry Oaks reserves the right to deal with each tournament as an independent event. Cherry Oaks reserves the right to make “on the spot” judgment calls in dealing with the given situation. The Clubhouse Manager and/or his staff will make every effort to reschedule or rectify the situation in an equitable manner.

Extra Golf Carts

In the event that a tournament will require more carts than are owned by Cherry Oaks, the extra golf carts will be rented by Cherry Oaks and in turn, rented to the tournament at no profit and no expense to Cherry Oaks Golf Course.

This provision will be strictly enforced

Final Arrangements

Once the tournament date and times are secured, the tournament coordinator or representative should make periodic contact with the Clubhouse Manager to finalize all details of the event.

COVID Related Acknowledgments and Release

The requestors of this Tournament (the “Releasers”) hereby request to utilize the services and facilities of the Cherry Oaks Golf Course, operated by the City of Cheney, Kansas. The Cherry Oaks Golf Course cannot prevent individuals from becoming exposed to, contracting, or spreading COVID-19 while utilizing the Cherry Oaks Golf Course’s facilities or services. It is not possible to prevent against the presence of the disease. Therefore, individuals choosing to utilize the Golf Course’s services or facilities may be exposing themselves to and/or increasing their risk of contracting or spreading COVID-19.

In this context, the Releasers understand that it is not only possible, but likely, that tournament participants will be in contact with citizens of the community at a distance closer than 6 feet. Releasers also understand and acknowledge the risks associated with such contact, including but not limited to those risks associated with the recent COVID-19 outbreak. However, despite these risks, Releasers desire to rent the facilities described in this Agreement and in exchange do hereby agree to waive any claims for personal injury or property damage against the City of Cheney and its officers, employees, agents, invitees and volunteers that in any way emanate from or relate to the tournament’s rental or use of the facilities or services referenced hereunder. Additionally, the tournament agrees to indemnify and hold harmless the City of Cheney and its officers, employees, agents, invitees and volunteers from any and all such claims referenced in this paragraph. The tournament acknowledges and agrees that said indemnification and hold harmless commitment includes but is not limited to the duty to defend the City of Cheney and its officers, employees, agents, invitees and volunteers from and against any and all such claims referenced in this paragraph.
